## **Full Terms and Conditions**

- b. The EF jersey is brand new, not worn before. The EF Jersey is the same that the team wears in competition. It is designed by Rapha and EF Education-NIPPO Pro Cycling. They are authentic team jerseys autographed by Lachlan Morton. The EF Jersey is valued at \$195 USD.
